4. MCC Liaison – Carolyn Bendall

4.1 Carolyn Bendall, MCC Committee Liaison to the WoMCC introduced herself and spoke briefly of the breadth of the MCC sporting sections and special interest groups. Carolyn spoke of the reinvigoration of the WoMCC that she has witnessed over the last 12 months, including a refreshed committee, formally revisiting the

mission, goals and strategic plan and ensuring alignment with the MCC Diversity & Inclusion Plan, engaging Jane Nathan as WoMCC Patron and a booked-out calendar of events and activities. Carolyn commended the WoMCC Committee on an excellent and progressive year.

5. Chair of the WoMCC Report

5.1 Report from the Chair of WoMCC Caroline Darcy.

2024 was a significant year for the Women of the MCC and my first as Chair. Acknowledging our history, the committee decided to come together to revisit our purpose, objectives, and set a refreshed vision for the future. We engaged an external facilitator for a strategic review, refining our purpose to:

"To help women get more from their membership by building a sense of belonging for women within the MCC".

As part of the strategic review process, we sought input from key individuals within the MCC. Our founder and current patron, Jane Nathan, shared important historical insights. Michelle Nolan, General Manager of People and Culture, guided us through the club's Diversity and Inclusion strategy, focusing on female engagement. We also received input and training from Gabrielle Keegan, Social Media Lead for the MCC/MCG channels.

Following two strategy workshop sessions, where we refined our purpose, objectives, and target audiences, many great ideas on how to best engage female members of the MCC and drive value for their membership were tabled. Keep an eye out for these exciting initiatives, which will be rolled out in 2025 and beyond.

Looking back on 2024, it was a year of tremendous growth for the Women of the MCC. We hosted more than 700 members and their guests throughout the year and enjoyed the following key highlights:

- > 40 years of female membership
- > Increase in our membership base (15%) & social media (10%)
- Successful strategic review workshops
- > Refreshed Women of the MCC strategy including purpose
- Connected and collaborated with MCC (D&I and social media)
- Introduced 3 new events:
 - Champagne celebration
 - Olympics Function
 - Women's Ashes Test
- ➤ Hosted new venue Australian Sports Museum

Our **Women in Cricket Breakfast** on Day 2 of the Australia vs. Pakistan Boxing Day Test featured emcee Tiffany Cherry interviewing guest speaker Isa Guha and hosting a Q&A with Karen Rolton and Cathryn Fitzpatrick.

Next was our **Women in Wine** event with winemakers Madeline Marson from Vinea Marson and Jodi Marsh from Sanguine Estate. Aligned with International Women's Day in early March, we hosted 159 members and guests in the Long Room.

This was followed by our **Women in Football** function in the Committee Room, featuring three Collingwood mums, Donna Brayden, Jane Harcourt, and Julie McCreery, who spoke about the Mother's Day theme and what it means to be the mother of an AFL player. In the future, we hope to align this function with Mother's Day, making it a marquee event on our calendar. And who can forget the heart-stopping win at the siren by the Magpies!

Our **Match Day function** between Richmond and Hawthorn in June coincided with Dusty's 300th AFL game. He didn't disappoint, kicking the first goal and bringing the crowd to their feet!

In October, we hosted our 3rd **Business Breakfast** with emcee Jacqui Felgate and guest speaker Sally Capp AO, former Lord Mayor of Melbourne. Partnering with Jaywing and Krispy Kreme, we welcomed 180 attendees in a fabulous atmosphere that fostered networking and connection. The event was a great success, receiving positive feedback.

As to our new functions, our first **Champagne Celebration** in November 2023 hosted 94 members and guests in the Committee Room. We celebrated the first year of our newly minted 50-year female members with three exquisite champagnes from Pommery. This relaxed function provided ample networking opportunities and was a great success.

Another new function this year, though not the first **Olympics function** hosted by the WoMCC, was our first event at the Australian Sports Museum (ASM). Held during the Paris Olympics on August 1st, it featured guest speaker Selin Kuralay OLY, an Olympian and former Matilda. The food stations and format allowed attendees to explore the richness of the ASM and the MCC Museum, receiving very positive feedback.

Looking ahead, we have our **End of Year Celebration** next week, themed "Cheers for 40 years of female membership," and our Women in Cricket Breakfast on Day 2 of the Boxing Day Test, which promises to be a great battle between Australia and India. In the early new year, we will also host two events during the **Women's Ashes Day/Night** Pinkball Test: Lunch on Day 1 in the Members' Dining Room and Dinner on Day 2 in the Committee Room.

To wrap up the Chair's Report, following is a summary of our key areas of focus and growth for 2025:

- **Refining our purpose and objectives**: We will continue to clarify and sharpen our mission to ensure it aligns with our members' needs.
- **Setting key targets for growth**: Establishing clear goals to expand our membership and enhance our impact.
- Governance development and revision of rules: Strengthening our governance framework to support our evolving organization.
- **New website launch**: Collaborating with the MCC on a new website presence for the WoMCC to improve our online presence and member engagement.
- **Increasing social media and communication competencies**: Enhancing our digital skills to better connect with our community.

- **Focusing on non-event elements**: Emphasizing thought leadership and mentoring to provide more value to our members.
- **Creating more social/informal connections**: Organizing casual meetups like coffee gatherings for members and past committee members to foster a stronger sense of community.

We are excited about these initiatives and look forward to connecting with you for a productive and impactful year ahead!

6. Financial Report of the WoMCC for the calendar year to 31st October 2024

6.1 Report from the Treasurer of WoMCC, Georgina White.

Good evening, Women of the MCC Members and Committee.

Our Financial Year runs from 1st November 2023 to 31st October 2024.

At 1st November 2023, the opening bank balance was \$37,644.44. This amount was held in one bank account but held 2 "pots of funds". Of this opening balance, \$11,605.66 was held for charity donations and the remaining \$26,038.78 as the operating/working balance. During the year we opened a new bank account at National Australia Bank for the charity funds to ensure they were managed separately.

Our financial report is prepared on a cash basis, so not all events are represented in their entirety. For example, the Business Breakfast is held in October so some receipts and payments for this event have occurred after the year-end.

Receipts

During this financial year, we received as follows:

- From function attendance \$80,884.60
- From Fundraising \$9,543.29; and
- From Sponsorships \$12,500, (\$5000 for the 2023 WBB and \$7500 for the 2024 WBB) Our sincere thanks to Jaywing and Krispy Kreme for their generous support of our 2024 WBB event.

Payments

We have paid \$94,128.64 in expenses, and \$1,000 in donations.

We made one charity donation for 2024; the \$1,000 was provided as financial support to the Waverley Softball Club for two of their young players who have recently been selected in the Victorian u16 Softball team.

Caroline has already covered the various events held this year, which overall have resulted in a small surplus; thanks to the Chairs and sub-committees of each event for preparing adequate budgets and careful monitoring of income and expenditure.

Balance at Year-End

The transactions for the year have resulted in a total cash balance at 31st October 2024 of \$45,443.69. This is reflected in bank accounts held at National Australia Bank:

As mentioned, there are still some expenses outstanding from the Women's Business Breakfast, but we maintain a healthy buffer in the working balance due to some profitable prior and current year events.

8. 2024 WoMCC Committee Election Results

8.1 Election results from the Vice Chair, Lucy Eastoe

As at the 2024 AGM, the WoMCC has three vacancies on our committee. An expression of interest was conducted and communicated to all WoMCC members. The WoMCC was fortunate to have several members express interest in the position, with six candidates seeking nomination. As a result of more candidates than vacancies, a ballot was conducted amongst all WoMCC Members.

Vice Chair, Lucy Eastoe on behalf WoMCC Committee, expressed thanks to Tatum De Silva, Rachael Dunne and Mimi Gibson for their nominations. We also

congratulate the two successful nominees Alicia Robson and Nicola Steele, who will join the committee for 2025, and Megan Shaw for her successful re-election.

9. Any other business

9.1 Questions from the floor

Has there been a consideration of putting the charity funds in a term deposit? Georgina responded that the charity funds were recently placed into a term deposit at 4.9% for 6 months whilst the Committee worked through the charity piece and governance of those funds. This will be reflected in the Financial Report for 2025. Lucy responded further that governance is a high priority, defining who we are, where we are going, how we will raise charity funds, and how we will distribute charity funds, including the possibility of sharing the charity funds with other aligned organisations.

Is the WoMCC money held separately from the MCC?

Georgina confirmed that the funds for the main account and charity funds were held by the Women of the MCC and separate to any MCC accounts.

Were the WoMCC aware of the Afghanistan refugee women were playing prior to the Women's Ashes in 2025?

Wendy, leading the Women's Ashes subcommittee, confirmed that it had been discussed with the MCC.

10. Meeting close

10.1 Jane Nathan, Patron of the Women of the MCC, addressed the AGM floor.


